BYLAW NO. 9-21

A BYLAW TO PROVIDE FOR THE CLOSING AND TRANSFERRING OF A MUNICIPAL ROAD OR ROAD ALLOWANCE

The Council of the R.M. of Val Marie No. 17, in the Province of Saskatchewan, enacts as follows:

- 1. Subject to the consent of the Minister of Highways and Infrastructure, the Municipality agrees, on the terms and condition set out in the agreement marked as Exhibit "A" which is attached to and forms part of this bylaw, to close and transfer the municipal roads and road allowances described as:
 - a. All the North/South Road allowances, East/West Road Allowances and intersections as shown on Schedule "A" attached to this Agreement.
 - b. All the North/South Road allowances, East/West road allowances and intersections as shown on Schedule "B" attached to this Agreement.
 - c. All the North/South Road allowances, East/West road allowances and intersections as shown on Schedule "C" attached to this Agreement.
- 2. This Bylaw is passed for the purpose of enabling Her Majesty the Queen in right of Saskatchewan to transfer to Her Majesty the Queen in right of Canada, the administration and control of all the said municipal roads, road allowances, road intersections and road plans in accordance with an agreement between the Province of Saskatchewan and the Government of Canada for the creation and establishment of the Grasslands National Park.
- 3. Bylaw 1-11 is hereby repealed.

AGREEMENT TO TRANSFER MUNICIPAL ROADS AND ROAD ALLOWANCES

Whereas:

The roads, streets, and road allowances ("the Roads") described as:

- a. All the North/South Road allowances, East/West Road Allowances and intersections as listed in Schedule "A" attached to this Agreement;
- b. All the North/South Road allowances, East/West road allowances and intersections as listed in Schedule "B" attached to this Agreement; and
- c. All the registered roads associated with the road plans as listed in Schedule "C" attached to this Agreement,

must be transferred to Her Majesty the Queen in right of Canada so that the Grasslands National Park may be awarded the full protections afforded through scheduling said lands under *The Canada National Parks Act*; and

Parks Canada is desirous of acquiring the Roads;

The Municipality is prepared to close and transfer the same to Parks Canada, pursuant to section 13 *The Municipalities Act*, on the condition that the registered roads listed in Schedule "C" to this agreement and the unregistered roads listed in Schedule "D" to this agreement, which have been used by the public generally to access lands in the area for many years, will remain open to local traffic as required in the future;

Whereas the Minister of Highways and Infrastructure has agreed to allow the Municipality to close and transfer the Roads to Parks Canada, subject to the terms and conditions hereinafter set forth.

Now therefore the parties agree as follows:

- 1. The Municipality shall close and transfer to Parks Canada the direction, control and management of all those roads identified in Schedules "A", "B" and "C".
- The transfer shall be subject to the laws of Saskatchewan and any applicable municipal bylaws or regulations.

- 3. Parks Canada shall continue to keep the roads listed in Schedules "C" and "D" to this agreement open and to allow local traffic to access the said roads and use the same as needed.
- 4. Should Parks Canada intend to make any changes to bridges located on any of the Roads, it shall ensure that the bridges will be capable of accommodating such weights as are customary for the agricultural operations being carried on in the Municipality.
- 5. Parks Canada undertakes to repair the deficiencies in the Walker [located at NW 24-02-11-W3] and Dixon [located at NW 3-2-11-W3] bridges within two years from the date of the transfer of the Roads to Parks Canada.
- 6. Parks Canada accepts the Roads in their present conditions. Parks Canada agrees to save harmless and keep indemnified the Municipality and the Crown in right of Canada or either of them from and against any future expenses, damages, claims, demands or judgments concerning the Roads.
- 7. Parks Canada shall be responsible for:
 - a) all costs to convey title to the land and any review for intended land use by Community Planning; and
 - b) all Information Services Corporation (ISC) fees related to the transfer of the land.
- 6. Parks Canada shall, without charge, grant utility line easements as may be required by the Saskatchewan Power Corporation, Sask Energy and Saskatchewan Telecommunications for any existing lines.
