BYLAW NO. 17-20

A BYLAW TO RESTRICT THE WEIGHT OF VEHICLES USING CERTAIN BRIDGES

Pursuant to Section 8 of The Municipalities Act, the Council of the Rural Municipality of Val Marie No. 17, in the Province of Saskatchewan enacts as follows:

Definitions

1. For the purposes of this Bylaw, in conjunction with *The Vehicle Weight and Dimensions Act, 1999* the following definitions are made:
 - a. "Farm Equipment" means equipment, that is designated and intended for use in farming operations but does not include any of the following:
 - i. a truck
 - ii. a semi-trailer
 - iii. a trailer
 - iv. farm equipment that is loaded on a truck trailer or semi-trailer; or
 - v. farm equipment that is towing equipment other than farm equipment
 - b. "Gross Vehicle Weight" (GVW) means the total weight of a vehicle or combination of vehicles calculated as the sum of the weight transmitted to the surface of a public highway through each of the axles;
 - c. "vehicle" means a device in, on or by which a person or thing is or may be transported on a highway and includes its load, and also includes any equipment that may be towed on a highway.

Bridges Restricted

2. The following bridges and associated weight restrictions are hereby set:
 - a. The bridge located on the road through section 30-05-15-W3 be restricted to vehicles and farm equipment with the following weights
 - i. GVW Two Axle Vehicle/Farm Equipment – 7.0 metric tonnes
 - ii. GVW Three Axle Vehicle/Farm Equipment – 8.0 metric tonnes
 - iii. GVW Five Axle Vehicle/Farm Equipment – 10.0 metric tonnes
 - ~~b. The bridge located on the road through section 29-04-17-W3 be restricted to vehicles and farm equipment with the following weights:
 - ~~i. GVW Two Axle Vehicle/Farm Equipment – 7.0 metric tonnes~~
 - ~~ii. GVW Three Axle Vehicle/Farm Equipment – 8.0 metric tonnes~~
 - ~~iii. GVW Five Axle Vehicle/Farm Equipment – 10.0 metric tonnes~~~~
 - ~~c. The bridge located in the NW 24-01-11-W3 be restricted to vehicles and farm equipment with the following weights:
 - ~~i. GVW Two Axle Vehicle/Farm Equipment – 7 tonnes~~
 - ~~ii. GVW Three Axle Vehicle/Farm Equipment – 14 metric tonnes~~
 - ~~iii. GVW Four Axle Vehicle/Farm Equipment – 19 tonnes~~~~
 - ~~d. The bridge located in the NW 03-02-11-W3 be restricted to vehicles and farm equipment with the following weights:
 - ~~i. GVW Single Two Axle Vehicle/Farm Equipment – 6 metric tonnes~~~~

~~ii. GVW Three Axle Vehicle/Farm Equipment — 11 metric tonnes~~

~~iii. GVW Four Axle Vehicle/Farm Equipment — 14 tonnes~~

Penalty

3. Any person found guilty of an infraction of any provisions of this bylaw shall be liable to the penalties set out in the General Penalty Bylaw of the municipality.

Repealing Clause

4. This Bylaw hereby repeals Bylaw 12-20.
